	Qualitative Analysis		

As of September 30, 2024, the Bank's leverage ratio was 8.83%, exceeding the minimum requirement. This 0.35% increase in the leverage ratio was primarily due to a decrease in the Bank's exposure by IDR 352 billion and an increase in capital by IDR 532 billion compared to the previous quarter.
